Implementation Plan for Replacement of Breath Alcohol Testing Instruments

EXECUTIVE SUMMARY

Problem Statement: The sole approved instrument in the State of Georgia for analysis of alcohol in breath samples (breath alcohol testing) is the Intoxilyzer 5000 manufactured by CMI, Inc. This instrument platform has been in place since the mid 1990's in local and state agencies across Georgia. Although functional and scientifically reliable, the Intoxilyzer 5000 does not possess all of the attributes necessary to meet evolving legal requests and quality assurance recommendations in the field of breath alcohol testing. There are also serious concerns about the long term ability to obtain replacement parts from the manufacturer. Selection and approval of a new instrument to replace the Intoxilyzer 5000, followed by training of local and state officers to utilize the new instrument will require a minimum of three (3) years.

Proposed Solution: The GBI Crime Lab will evaluate and select a replacement instrument for the Intoxilyzer 5000 during 2012. Instruments from three vendors have been leased for the purposes of the evaluation. A detailed evaluation plan has been developed that includes participation of officers from local agencies at the appropriate stages. A schedule for instrument replacement and officer training is presented in this document as guidance to local and other state agencies for planning and budgetary purposes. With appropriate funding support from the state, federal grants, and local jurisdictions, all breath alcohol testing instruments in the state should be replaced no later than the end of calendar year 2015.

Implementation Cost: The total cost to state agencies should not exceed \$300,000. This includes instruments installed at the Georgia Public Safety Training Center to train local officers and those used by Georgia State Patrol officers in support of the program. The cost per instrument to local agencies should be \$8000-\$10,000 depending upon the final instrument selection and configuration. The GBI Crime Lab will establish a statewide contract with the selected vendor for use by local agencies to simplify the procurement process as much as possible. Local agencies will also need to provide necessary supplies for ongoing routine quality assurance measures to ensure proper instrument operations so that breath alcohol test results can be successfully introduced into court proceedings.

STATEWIDE UPGRADE OF EVIDENTIAL BREATH ALCOHOL TESTING DEVICES

PLAN OVERVIEW

Issues:

(1) Aging Fleet

The Intoxilyzer 5000 has been the only evidential breath testing instrument utilized in the state of Georgia since 1995. As of the end of 2011, there are approximately 503 active Intoxilyzer 5000s, with an average age of 9.5 years. An analysis of instruments being put "out of service" for repair or storage revealed a 240% jump in the number of "out of service" instruments from year 9 to year 10 of active service. With the majority of the instruments in the current fleet approaching 10 years of active service, a jump in the number of "out of service" instruments at 10 years of service would sharply decrease the number of instruments available for testing when needed.

Some of the original Intoxilyzer 5000 components such as the internal printer are no longer available. Approximately 119 instruments currently in use are greater than 13 years old and are based on a platform that could render them unable to be repaired should they experience an internal printer failure.


(2) Quality Control


While the Intoxilyzer 5000 is still functionally sound, it suffers some limitations in the ability to adapt to the changing forensic and legal landscape. Agencies such as the National Safety Council are recommending implementation of new measures to ensure tighter control of quality assurance. A growing number of criminal court cases are requesting large volumes of electronic test information that the Georgia Intoxilyzer 5000 as configured does not have the ability to provide. In addition, the Georgia Intoxilyzer 5000s are not configured with the capability to schedule quality control checks at the frequency recommended by a growing number of experts in the forensic community. This has led to an increase in the number of courtroom challenges to the Intoxilyzer 5000's reliability.

(3) National Trends

Many states are now replacing their Intoxilyzer 5000s with newer, more PC compatible models. New instrument sales of the Intoxilyzer 5000 have been eclipsed by the Intoxilyzer 8000, and with the unveiling of the new Intoxilyzer 9000 it is reasonable to assume that CMI will continue to shift more of its focus to the newer products over the next several years.

Impact:





Solution:

In order to address these issues we propose a five year phased evidential breath testing instrument replacement plan.

- I. We propose a one year evaluation and selection period to completed during calendar year 2012 consisting of the following:
 - a. Three major evidential breath testing instruments will be evaluation as successor to the Intoxilyzer 5000. The units to be evaluated are the CMI Intoxilyzer 9400, National Patent Datamaster DMT-GF, and the Nanopuls Evidenzer 240 mobile. While the cost of these models varies based on their specific configuration, the estimated instrument cost is expected to be between \$8000 and \$10,000. Additional costs associated with implementation of these instruments include integration into new or existing data lines for remote data collection and the purchase of consumable dry gas standards to be used during periodic calibration checks.
 - b. The laboratory testing phase of instrument evaluation will apply uniform testing criteria to evaluate instrument accuracy, precision, specificity, limits of detection, durability, and compatibility with data storage and retrieval. These tests will also seek to address any concerns over design limitations for particular models.
 - c. The administrative phase will consist of evaluation of the instrument's and manufacturer's reputation in the scientific community and its ability to serve the specific needs of the Georgia breath testing program.
 - d. The field study will consist of an evaluation of proposed evidential breath testing instruments under field conditions.
 - e. Ten to twelve officers selected from sheriff's and police departments who are already certified to perform breath analysis for alcohol will be selected to utilize the evaluation instruments and provide feedback regarding ease of use and suitability for end users.
 - f. Once the evaluation period is complete, a report summarizing the findings of the evaluations will be generated and one or more instrument(s) will be selected.
 - g. Once a new instrument is selected, the process of updating the current testing method for incorporation of the new instrument will be completed (by the end of 2012).
 - h. Once procedure revisions are complete, the GBI will file for changes to GBI Rule 92-3 to reflect the new instrument(s) approval and procedure updates.
 - i. All agencies will be notified of testing procedure changes and will be provided with a phased plan for instrument replacement.
- II. Training and implementation for the new instrument(s) will be phased in over three calendar years beginning in 2013.
 - a. All Implied Consent staff from GSP will receive factory training on the new instrument theory, operation, and maintenance.
 - b. Instruments will be obtained for personnel attached to the Implied Consent Unit to assist in field recertification of current operators on the new

- evidential breath testing instrument and procedure changes. Approximate $\cos t$ \$100.000
- c. New instruments used for training new operators at the Georgia Public Training Center in Forsyth will be purchased and installed. Approximate cost \$200,000.
- d. Training of existing operators at GPSTC on the new breath testing instrument will begin in 2013. Recertification classes on the Intoxilyzer 5000 will be gradually phased over to new instrument transition classes according to demand. All Intoxilyzer 5000 operator permits will reflect an expiration date of December 31, 2015 while new instrument operator permits will continue to be valid for four years from date of issuance.
- e. Regional and onsite transition classes will be developed to train existing operators on the new instrumentation in convenient strategic locations. The number and location of these classes will be dependent upon logistical considerations and available resources. The expected class length will be between 4 and 8 hours.
- f. By June 30, 2013, classes for new operators will begin transitioning from Intoxilyzer 5000 based classes to classes utilizing the new breath testing instrumentation. The number of classes offered for each instrument will be dependent upon demand.
- g. Agencies may voluntarily choose to implement the new instrument(s) beginning July 1, 2013.
- III. 2014 will be the second year of the phased implementation plan.
 - a. The GBI will require replacement or inactivation of all instruments beginning with serial numbers 68-00 by December 31, 2014. These instruments were all fielded prior to 1999 and comprise approximately 23% of the current fleet.
 - b. Training of new operators on the Intoxilyzer 5000 will continue to transition to new instrument training classes.
 - c. The Implied Consent Unit will continue to train personnel on the new evidential breath testing instrumentation.
 - d. Agencies may voluntarily choose to implement the new instrument(s). The Implied Consent Unit will continue voluntary replacement of evidential breath testing instruments at the request of the agency.
- IV. The third year of the implementation plan (2015) will be completed calendar year 2015 and will consist of the following:
 - a. All remaining Intoxilyzer 5000s will be replaced or inactivated by the end of calendar year 2015.
 - b. GBI will cease all inspection and certification operations on Intoxilyzer 5000 instruments by the end of 4^{th} quarter 2015.
 - c. All Intoxilyzer 5000 operator permits will expire as of December 31, 2015.
 - d. 100% of all training classes will cover the new evidential breath testing instrumentation.

The Datamaster DMT – GF is a new dual technology evidential breath testing device that utilizes a three filter infrared detector system in conjunction with an electrochemical or fuel cell to measure alcohol content in a subject's breath. All DMTTM configurations include a touch-screen graphics display, an embedded PC and multiple USB ports. The DMT utilizes a real-time graphics display of breath profile and alcohol curve during a subject test. The DMTTM is a lightweight, portable unit capable of being used on a wide range of AC power, 12VDC and internal batteries for mobile use. In-house database management and communication software package (DM Host) is available for use with any DMT instrument. While there are no states that currently use the DMT-GF configuration, the Datamaster Series of instruments is currently in use in eleven states:

The Evidenzer Mobile 240 is a five filter evidential infrared breath testing device recently available for sale in the United States. The Evidenzer Mobile 240, running Windows CE, is designed for use in an office environment and in tough mobile environments. It has a high resolution 240x320 color screen with a built-in thermo printer. Customized reporting and database systems with local or remote access are available options. The very large data memory, up to 4 Gigabytes, allows the instrument to store all data collected during an evidential test. This includes the complete "exhalation profile" for all five or seven sampled wavelengths with ten samples per second for each wavelength. The Evidenzer Mobile 240 can also be equipped to measure subject breath alcohol temperature during the breath test. The Evidenzer can operate between 32°F and 104°F using standard 120V AC or 12V DC power supply. While the Evidenzer is not currently used in the U.S. it has been approved by the U.S. DOT/NHTSA and the international standard OIML R126E (1998). Countries currently using the Evidenzer are:

The Intoxilyzer 9400 is a four filter evidential infrared breath testing device newly released for sale in the U.S. market. The Intoxilyzer 9400 is the only evidential breath testing instrument on the market that analyzes four infrared wavelengths in the 9 micron region to identify and quantify alcohol. The 9400 eliminates some of the high maintenance moving parts by utilizing a pulsed infrared source, thereby eliminating the need for a chopper motor. The instrument interface consists of a 7" color touch screen display driven by a Windows CE software platform. The 9400 can operate between 32°F and 104°F using standard 120V AC or 12V DC power supply. The entire breath profile can be preserved and transmitted to a centralized database for storage and analysis using vendor supplied software.
